Summary

The Government of Karnataka has made ragging a cognizable offense punishable with imprisonment, and holds the Principal responsible for making the College ragging-free. VTU is keeping a strict vigil to prevent any sort of ragging. Under the direction of the Supreme Court of India, authorities have asked colleges to take necessary measures to prevent ragging.

Students are severely warned that

- 1. Ragging of any kind is strictly prohibited by law both inside and outside the campus.
- 2. Offenders will be dismissed from the College and the hostel and reported to the police.
- 3. Photographs of offenders will not only be displayed on the notice board, but also published in newspapers.
- 4. Offenders cannot appear for university examinations.\
- 5. Names of offenders will be sent to VTU, which will record the fact in the marks card.

There is no such thing as friendly ragging or mild ragging. All forms of ragging are dehumanizing and go against our value system. The College will not take a lenient view of any instance of ragging. The College has formed an ANTI-RAGGING COMMITTEE. Apart from the Vice Principal, senior teachers and senior students as members, media persons and the police authorities are represented in this committee. Please do not hesitate to approach any of them. They will ensure confidentiality also. Freshers are advised to make a note of their names. Any student who becomes a victim of ragging of any kind must report to the anti-ragging committee without any fear and the college will take strict action.

INTIMATION TO PARENTS

There is an absolute ban on ragging in the College. The Supreme Court and the Government of Karnataka prohibit any act of ragging. Exemplary punishment including filing of an FIR with the police, entry of the participation of the crime in all certifications and expulsion, will be handed out to any defaulters. Any student found ragging faces expulsion from the college for a term (six months), with payment of tuition fees for term and fine of Rs.25,000/-, vacating the hostel, cancelling scholarships, debarring from representing Institutions in tournaments, youth festivals etc. The onus to prove innocence will be on the one accused. UGC has clarified that regulations cover the entire premises of Educational Institutions, including canteen, playground and all means of transport for students.




Fig 2: Banner in college mess and Boys hostel.




Fig 3: Banner in college mess and ladies hostel.

, ASI Balakrishna and team members of konaje police station & head of the

department, and others were present.

Later the session was handed over to PSI Mallikarjun Sir, he spoke about the roles and responsibilities of the students and to follow all the rules. He told Ragging is a cognizable offence (offence for which the police can arrest the offender without warrant). This heinous practice has caused deaths and suicides of many bright students in the recent past in India, forcing the Supreme Court to take a serious view of the menace, and recommend deterrent and justifiably harsh punishment to those guilty of ragging. So, a ragging complaint against a student, if found valid after investigation, can straightaway become a criminal case and land the perpetrator in serious trouble. The Institute is bound to take strong action against him or her, and regardless of this, the law of the land will catch up with the offender with hard punishment. He also told students should be away from the drugs. He stated that the institute should be zero tolerance to ragging.

Responsibilities of Anti Ragging Committee

On receipt of the recommendation of the Anti Ragging Squad or on receipt of any information concerning any reported incident of ragging, the Head of institution shall immediately determine if a case under the penal laws is made out and if so, either on his own or through a member of the Anti Ragging Committee authorized by him in this behalf, proceed to file a First Information Report (FIR), within 24 hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely:

Abetment to ragging

- · Criminal conspiracy to rag / Unlawful assembly and rioting while ragging
- Public nuisance created during ragging, Violation of decency and morals through ragging
- Injury to body, causing hurt or grievous hurt o Wrongful restraint
- · Wrongful confinement
- · Use of criminal force
- Assault as well as sexual offences or unnatural offences
- Extortion /Criminal trespass
- Offences against property
- Criminal intimidation
- Attempts to commit any or all of the above mentioned offences against the victim(s)
- Threat to commit any or all of the above mentioned offences against the victim(s) Physical or psychological humiliation
- Other offences following from the definition of "Ragging". Responsibilities of Squads In charge of Anti Ragging Committee

Squads In charge will be Responsible for the following in their areas:

- They will form duty chart & carryout regular checks for any Ragging activity in their areas.
- They will carry out surprise checks in probable areas of ragging.
- In case of any incidence noticed on the spot, assessment of the incidence be made and necessary action to be taken and inform the control cell immediately in given Performa.
- Ensure anti ragging instructions are displayed at prominent places in their areas of control.

- Each squad in charge will make detailed duty plan in respect of his squad and forward a list copy of the same to the control room.
- Every squad in charge will brief all members of his squad about their duties
 / action regarding anti ragging.
- In case of inadequacy of the member detailed in their respective teams, they may float additional requirements to the in charge of anti-ragging committee.
- The squad in charge will collect the updated list of student including their latest address and phone no's in respect of the classes run in their blocks of their areas. Any member of the squad not performing his duty properly will also be communicated to the control room as per the Performa given.
- For communication with the in-charge of anti-ragging committee and control room following telephone no's furnished at the end.

As you are aware, in pursuance to the judgment of the Hon'ble Supreme Court of India and in compliance of All India Council for Technical Education (Prevention and Prohibition of Ragging in Technical Institution, Universities including Deemed to be Universities imparting technical education) Regulations 2009, it is compulsory for each student and his/her parent/Guardian to submit an online undertaking each academic year at either of the two designated web sites, namely, www.amanmovement.org.

As part of UGC's initiative toward reduction of compliance burden of its stakeholders, UGC has revised the procedure for students to file online Anti Ragging Affidavit (A copy of the revised procedure is enclosed).

The revised procedure is as follows:

- Step 1: A student will submit his/her details on the same web sites (www.amanmovement.org) as before; read and confirm that he/she and his/her parents/Guardians have read and understood the AICTE regulations on curbing the menace of ragging. He / She will confirm & agree that he/she will not engage in ragging in any form. (Step 1 is the same like before).
- Step 2: The student will receive an e-mail with his/her registration number and a web link. The student will forward the link to the e-mail of the Nodal Officer in his/her university/college. (please note that the student will not receive pdf affidavits and he/she is not required to print & sign it as used to be the case earlier).
- Step 3: The Nodal Officer in the University/College can click on the link of any forwarded e-mails that he/she will received from any student of his/her college to get the list of those students who have submitted Anti Ragging Affidavits/Undertakings in his/her college. The list will be updated every 24 hours.



He/She will confirm & agree that he/she will not engage in ragging in any form. (Step 1 is the same like before).

Action Taken by the College:

Formation of Committees & Squads: Complying with the directives of the Hon'ble Supreme Court of India, the college has formed the following Anti-ragging committees and squads for tackling the menace of ragging and overseeing the implementation of the provisions of the verdict with immediate effect:

Anti-ragging Committee:

The committee is constituted under the leadership of the principal, with the following members. The committee will meet periodically to review the situation and initiate effective measures. Depending upon the necessity the committee will also meet in the hostel. The committee as a whole or in separate groups will

Anti-ragging Flying Squads:

Anti-ragging flying squads under the chairmanship of the Head of Departments / Wardens will continuously and at all times shall take precautionary measures to see that no ragging takes place inside the class room, within college premises, hostel premises and other outside surrounding places.

Permanent hoardings have been erected in prominent places with in the campus to insist the students to prevent or not to indulge in ragging and also indicating there in the names of the officials and their telephone numbers to be contacted in case of ragging.

Undertaking from Students and Parents:

Each of the student of the College and his/her parents or guardian are hereby required to submit a combined undertaking at the time of registration, in the prescribed format, which is mandatory for registration. All concerned officials of the Institute, students, parents & guardians of the students, members of Anti-ragging committees & Anti-ragging squads are hereby requested to adhere to the stipulations and effectively monitor and comply with the provisions made in the directives.

What Constitutes Ragging:

Ragging constitutes one or more of any of the following acts;

Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or other student Indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any

fresher or any other student. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or

generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.

Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.

Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.

Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.

Any act of physical abuse including all variants of it; sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gesture, causing bodily harm or any other danger to health or person;

Any act or abuse by spoken words, emails, post, public insults would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;

Any act that affects the mental health and self –confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

RAGGING PUNISHMENTS

Ragging is totally prohibited in the institution, and anyone found guilty of ragging and / or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished. The institution may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely:

Suspension from attending classes and academic privileges

- Suspension from the institution for period ranging from one to four Semesters.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specific period.


